Information about the duty of supervision for children

Dear workshop participants, dear parents,

We, the Sharing the Presence GmbH, are pleased that participants also accompanied by children will take part in our workshop from July 28 - August 3, 2024 in Oberlethe. As the safety of the children is important, we would like to point out the following to the participants:

We ask for your understanding that we, Sharing the Presence GmbH, our legal representatives and our vicarious agents cannot and will not assume any supervision for children, especially for organizational and insurance reasons. A transfer of the duty of supervision to us, Sharing the Presence GmbH, or our staff, including our legal representatives and our vicarious agents, will not take place.

The duty of supervision for children remains with their parents. Minors (persons under the age of 18) may only enter and remain in or on the event building and grounds under the supervision and in the company of their parents or a parent, and only to the extent permitted by us. Parents must supervise their children at all times and, in particular, instruct them about dangers as appropriate to the circumstances and supervise them.

Special Notice:

We further point out that there is a lake on the premises. This lake is not secured from entering, nor is the shore sufficiently fortified. Playing at and in the lake as well as bathing in it are not permitted. There may be a risk of drowning. We therefore recommend that parents take special care here and not allow children near the lake or on the premises ever unsupervised, and that they be especially instructed about the dangers of the lake and that they be supervised at all times. We, Sharing the Presence GmbH, do not assume any supervision in this respect either.
