## Information on the duty to supervise children

Dear workshop participants, dear parents,

we, Sharing the Presence GmbH, are pleased that participants will also be accompanied by their children at our workshop from July 26 - August 1, 2026 in Oberlethe. As the safety of the children is very important, we would like to draw your attention to the following:

We ask for your understanding that we, Sharing the Presence GmbH, our legal representatives and our vicarious agents cannot and will not supervise children outside of childcare and childcare hours, in particular for organizational and insurance reasons.

**A transfer of the duty of supervision to us, Sharing the Presence GmbH, or our staff, including our legal representatives and our vicarious agents, expressly does not take place.**

The duty of supervision for children brought to the workshop remains with their parents. Minors (i.e. persons under the age of 18) may only enter and remain on or in our event grounds and buildings under the supervision and in the company of at least one parent and only to the extent permitted by us. Parents must supervise their children at all times and, in particular, instruct them about dangers and monitor them in accordance with the circumstances.

### **Special note: Lake on the event site!!!**

We would also like to expressly point out that there is a lake on the site. This lake is not secured against people entering it, nor is the shore sufficiently paved. Playing on and in the lake and swimming in it are not permitted. There is a risk of drowning.

We therefore recommend that parents take special care here and never leave children unattended near the lake or on the grounds, and that they are especially instructed about the dangers of the lake and supervised at all times. We, Sharing the Presence GmbH, do not assume any supervision or liability in this respect either.

## **Information on CHILD CARE**

We offer free childcare for children aged 3 to 12 years (inclusive), if you require childcare. This must be indicated during the registration process. This allows both parents (partners) to participate fully in the workshop.

**Childcare times: 10:30 am - 1:30 pm and 3:30 pm - 7:00 pm.**

**The following agreement applies: If a child does not wish to remain in care, a parent must come out of the workshop to look after and care for the child independently.**

**The child and its well-being always have top priority.**

### **Children under 3 years**

For children under 3 years of age, one parent (partner) is exempt from the seminar fee in order to take over supervision independently.

### **Children over 12 years**

We ask for your understanding that we, Sharing the Presence GmbH, our legal representatives and our vicarious agents cannot and will not supervise children over the age of 12, in particular for organizational and insurance reasons.

A transfer of the duty of supervision to us, Sharing the Presence GmbH, or our staff, including our legal representatives and our vicarious agents, expressly does not take place.



## Childcare

Dear workshop participants, dear parents,

We are delighted that you are taking part in this year's Summer Intensive Workshop and would like to use the childcare facilities for your children.

We expressly ask you to make sure that you give your children enough time to arrive safely at the respective childcare providers and only go to the events when your children have really "landed". You are always welcome to simply spend a morning or afternoon there with your children or to visit your children in between.

**And very important:** Please always pick up your children on time, i.e. at 1:30 p.m. or 7:00 p.m., even if the time in the seminar hall is exceeded. It is unpleasant for the children if they have to wait while other children are already being picked up.

Below we have a few organizational questions that we ask you to answer and bring with you to the respective childcare tent on the first day. **It is important to note that if your child does not want to stay in the childcare, a parent must come out of the workshop to look after the child. The child and its well-being always have top priority.**
